**Notification**

In exercise of the power conferred by section 38 of the Right of Children to Free and Compulsory Education Act, 2009(Central Act no 35 of 2009), the Governor is pleased to make the following rules to further amend in the the Uttarakhand Right of Children to Free and Compulsory Education rules, 2011, namely:-

**The Uttarakhand Right of Children to Free and Compulsory Education  
(Amendment) Rules, 2017**

Short title and Commencement	1.	(1) These Rules may be called the <b>Uttarakhand Right of Children to Free and Compulsory Education (Amendment) Rules, 2017.</b> (2) It shall come into force at once.
Amendment of sub-rule (c) and (f) of rule 34	2.	In the Uttarakhand Right Of Children to Free and Compulsory Education Rules, 2011, the existing sub-rule (c) and (f) of rule 34 as set out in column-1 below, the rule as set out column-2 shall be substituted, namely-
<b>Coulumn-1</b>		<b>Coulumn-2</b>
<b>Existing rule</b>		<b>Hereby substituted rule</b>
(c) Defining the expected learning outcomes of children at the end of each grade and for every subject and bringing out textbooks and learning material based on these outcomes;		(c) To implement the learning outcomes developed by the Central Government and translated in Hindi language by the State Government for all subjects and classes at elementary level in each school.
(f) Preparing suitable guidelines for implementation of continuous and comprehensive evaluation for all classes from classes I to VIII.		(f) To prepare guidelines for the implementation of continuous and comprehensive evaluation to achieve defined learning outcomes.
